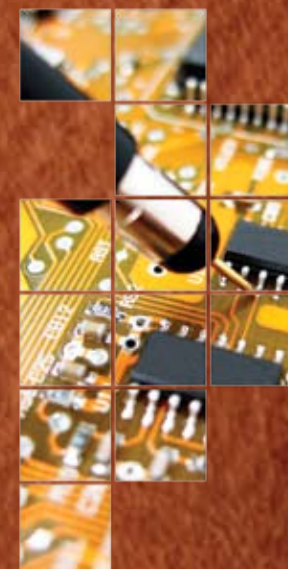

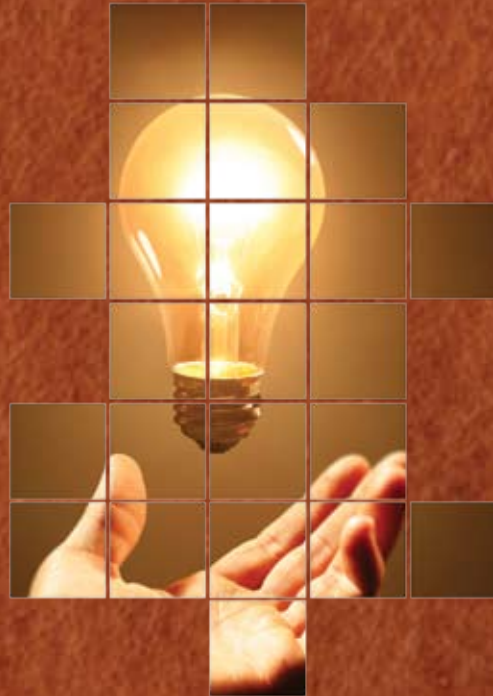

Recent U.S. Supreme Court decisions and changes to the Patent Laws highlight the ongoing importance of patents in a global economy benefitting from rapid technological advances.

A patent provides a legal monopoly for a substantial period, giving the owner the right to exclude others from making, using, selling or offering to sell a patented invention or design.

A "Utility Patent" protects the way a novel invention is used and works... the functional aspects of an invention. A "Design Patent" protects the novel way a product looks... the ornamental shape or appearance of an invention.

TRADEMARKS

Trademarks and Service Marks are distinctive words, phrases, designs, sounds, symbols, and special color combinations, or the like source identification, which identify the source of goods or services. Through purchasing experience, the public associates a mark with a single source, permitting reliance on a standard of quality, performance and safety.

Trade Dress Rights protect the distinctive shape, packaging, or design of products or the presentation and overall design of service establishments.

COPYRIGHTS

A copyright is a form of protection granted to the creators of "Original works of Authorship".

A Copyright provides its owner with a bundle of rights to exploit and maximize the economic value of the copyrighted work.

Copyright protection extends to artistic design, computer source code, books, maps, blueprints, photographs, web sites, catalogs, advertising, music, lyrics and much more.
